What is Jindal India thermal power?

The company has two 600MW coal-based power plants in Angul, northeastern India, run by its Jindal India Thermal Power. JIRE aims to generate power from 5GW of solar, wind, hybrid and FDRE [firm and dispatchable renewable energy] modes. It also intends to manufacture PV cells and modules to meet demand for solar power, according to reports.

Who is BC Jindal Group?

Will India invest in two coal-fired power plants in 2024?

In January 2024, the government's Cabinet Committee on Economic Affairs sanctioned equity investments of Rs56.07bn by Coal India subsidiaries in two coal-fired power projects. They will be made by South Eastern Coalfields and Mahanadi Coalfields to establish power plants with a combined capacity of 2.26GW.
