Who owns seneko power?

Engie was part of a consortium known as Lion Power, led by Marubeni, which, in 2008, bought Seneko Power from Temasek Holdings for S\$3.65bn in cash and assumed its debt totalling S\$323m. Other Lion Power shareholders include Kansai Electric Power, Kyushu Electric Power and Japan Bank for International Cooperation which own 40% between them.
