Inverters for Solar Power Generators (both diesel and Petrol propelled) SI 32 of 2008 did not include solar panels as the substantive duty rate for solar panels had been set at 0% in the First Schedule to the Customs and Excise Act (also known as the Customs Tariff Book) since 1999. Egg incubators have also been set at 0% since 1999.

The South African Revenue Service (SARS) has announced a 10% import duty on solar photovoltaic (PV) panels, cells, and modules. This change, listed under tariff subheading 8541.43 in the Customs and Excise Act, raises the duty on crystalline silicon photovoltaic modules or solar panels from free to 10% ad valorem.

What are the Standard Industrial Classifications Codes (SIC) and commodity codes for string inverters, central inverters, MVPS, and spare parts. The UK government provides an online service to check the UK Global Tariff that will apply to goods from 1 January 2021.

Inspired by similar policies in the US, the application was lodged by ARTsolar - South Africa's only 100% locally-owned solar panel manufacturer - which reasoned that a number of photovoltaic module or panel manufacturers had ceased their production operations in the Southern African Customs Union, due to high competition from low-priced imports.

Customs duty exemption on active energy controller (AEC) for use in manufacture of renewable power system inverters will also lapse from September 30. To boost battery manufacturing, BCD exemption for parts and raw material for use in the manufacture of lithium-ion cells is being extended up to March 31, 2026.
