Your home or business will automatically use your solar electricity before you buy any from the grid. Example: Your home has an electrical demand right now of 2.5 kW. Your PV system, right now, is producing 3 kW.

Finding an unshaded spot is best, but sometimes shading is unavoidable. Some solar panel systems can minimise the impact of shading using "optimisers".
