Gas from these fields is commingled at the Spirit-operated Chiswick Normally Unmanned Installation (NUI) and transported to the J6A platform via an 18 km, 10-inch pipeline. Similarly, the Grove field, where Spirit holds a 92.5% equity interest, also commenced production in 2007.
