ESERA was established by an act of parliament, the Energy Regulatory Act, 2007, which gives it the statutory right to regulate the electric power industry in Eswatini. The establishment of ESERA by legislation enhances the credibility of the institution and is likely to have a positive impact on investor and consumer confidence.

This policy brief examines the complex interplay of factors shaping Eswatini's energy landscape, from security to coal development's environmental, economic, and social implications. It outlines a roadmap for a Just Energy Transition in the Kingdom.

Energy development in Eswatini is guided by the National Energy Policy of 2018. Since then, the country's energy sector has been undergoing rapid transformation with the liberalization of the electricity sector to encourage private sector investment.

Total installed generation capacity is 69.6 megawatts, of which 60.1 mega watts is from hydropower, which contributes to 16.4% to the total country"s energy consumption while local Independent Power Producers (IPPs) contribute 4.75%.
