Was Devon scammed when buying solar panels?

Devon, among others in the southwest, was scammed when buying solar panels. A businessman has been sentenced to 30 months in jail and banned from being a company director for six years for his part in the scam.

How many people have been sentenced for solar panel fraud?

The 6 offenders were sentenced by His Honour Judge Warnock: Six men have been sentenced for a total of just over 30 years for their part in a £17 million solar panel fraud scheme.

How much money has been seized from a fraudulent solar panel scheme?

Two men who scammed millions of pounds from 760 vulnerable victims in a fraudulent solar panel scheme have today been ordered to pay confiscation totalling £413,206.10.

For many, if not most, consumers, solar panels are unable to produce enough electricity to offset the cost to purchase and install them. If a solar panel sales person promises something that sounds too good to be true--it probably is. ...

Intelligent Solar Limited operated from Taunton and then Torquay from 2015 to 2017, selling solar PV panels to consumers and arranging for their installation. One of their selling points was that customers, with "eligible" solar PV, could claim payments from the government, called Feed-in Tariffs, for energy created.

To submit your complaint, start by researching which industry association is relevant for your situation. For example, if you have an issue with installation quality or safety concerns related to solar panels on your roof, consider contacting The Solar Energy Industries Association (SEIA).
