When will the new feed-in tariffs for solar energy be regulated in France?

Paris/Freiburg/Berlin - Since last year, the French solar industry has been waiting for the new decree of 12 January to be issued regulating the new feed-in tariffs for solar energy. The new decree was finally published on 14 January, and is now valid for solar plants not yet in operation.

Are solar panels a good investment in France?

As electricity prices continue to soar in France - up 60% in four years - more people are turning towards solar panel kits, which promise to help users save on energy costs and installation prices. The estimated extra cost of electricity in 2024, compared to 2020, is EUR540 per household per year.

Will French government ease subsidising rooftop solar projects?

The French government last week unveiled plans to ease the mechanism for subsidising rooftop solar projects and put a cap on the reduction of feed-in tariffs (FiTs) for larger projects.

Are French solar installations bolstered by a new law?

Beyond falling prices, the IEA PVPS report said solar installations were bolstered by the measures introduced in the French government's Law for the Acceleration of Renewable Energies which came into force in 2023. Can solar panels work in winter in France?

The above-mentioned payments are limited to 1,500 hours of sunshine p.a. for mainland France and 1,800 for French overseas territories. For adjusted solar plants, the limit is 2,200 for mainland France and 2,600 for overseas territories. All electricity produced above this limit are remunerated with 5 eurocent per kWh.
