Does Freyr have a Gigafactory?

Norwegian battery cell company FREYR Battery (NYSE:FREY) today unveiled plans for a multi-phase battery cell production facility in the US state of Georgia that would require a total investment of more than USD 2.6 billion (EUR 2.61bn).

Who is Freyr battery?

FREYR Battery is a developer of clean, next-generation battery cell production capacity. The Company's mission is to accelerate the decarbonization of global energy and transportation systems by producing sustainable, cost-competitive batteries.

Where are Freyr batteries made?

FREYR has commenced building the first of its planned factories in Mo i Rana, Norway and announced potential development of industrial scale battery cell production in Vaasa, Finland and the United States. FREYR intends to install 50 GWh of battery cell capacity by 2025 and 100 GWh annual capacity by 2028 and 200 GWh of annual capacity by 2030.

Is Freyr building a Gigafactory in Norway?

FREYR is already building a Gigafactory in Norway- the Giga Arctic project in Mo i Rana, and has plans for industrial-scale battery cell production in Vaasa, Finland. The company's objective is to install 50 GWh of annual battery cell capacity by 2025, 100 GWh by 2028, and 200 GWh by 2030. (USD 1 = EUR 1.005)

Will Freyr supply Nidec?

FREYR first announced a broad partnership with Nidec in August 2022. The formation of this joint venture catalyzes a firm sales contract under which FREYR will supply Nidec with 38 GWh of next-generation, clean battery cells from 2025 - 2030. About FREYR Battery
