Genex Power has successfully reached financial close for the 50MW Phase One of Kidston solar project in Australia. For the financial close, Genex has entered into a debt funding arrangement for \$100m with French financial services company Soci&#233;t&#233; G&#233;n&#233;rale (Soc Gen) and Australian Government-owned Green Bank Clean Energy Finance Corporation (CEFC).

The PPA is subject to financial close by Genex on the project by the end of 2024 and Fortescue's final investment decision on its Gibson Island project by the end of 2023. Genex and J-Power are committing to the first stage of the project with a minimum capacity of 450MW. The PPA is expected to account for 75% of the revenue stream.
