In 2019,its government signed a deal with Karpowership,one of the world's biggest floating power plant operators,to supply the country with all its power. A spokesperson for the company told the BBC that Karpowership was &quot;grateful&quot; for Guinea-Bissau's efforts to pay the bill,which made it possible to resume electricity supplies.

Does Guinea-Bissau have electricity?

Guinea-Bissau has one of the lowest electricity connection rates in Africa,estimated at 10% nationally and 20% in the city of Bissau,according to the African Development Bank. Power outages in Bissau are frequent,with some parts of the city going without power for more than four hours a day.

Why does Guinea-Bissau need a renegotiated contract?

The country is one of the poorest in the world and has been beset by instability since independence. The government signed a contract with Turkey's Karpowership on 11 October to boost power supply to the capital, Bissau. The contract is for five years, with an option to renew, and is for 30MW, with 18MW to be supplied in a first phase.
