Will Liberian government sell 10% of West Africa's land to blue carbon?

In the past year, the Liberian government has agreed to sell about 10% of the West African country's land -- equivalent to 10,931 square kilometers (4,220 square miles) -- to Dubai-based company Blue Carbon to preserve forests that might otherwise be logged and used for farming, the primary livelihood for many communities.

Will Liberia grant reforestation rights to a private Emirati company?

ZOHRA BENSEMRA / REUTERS Liberia is preparing to grant the exclusive rights of over 1 million hectares of forest, about 10% of the country's land area, to a private Emirati company that will be tasked with marketing the carbon credits obtained from conservation or reforestation projects.

Are carbon credits legal in Liberia?

"There is no legal framework on carbon credits in Liberia, and so we don't have rules and regulations to fight for ourselves as a community," said Walley, whose community, Neezuin, could see about 573 square kilometers signed away to Blue Carbon.

Will Liberian & UAE agree to transfer pollution rights?

According to a confidential and still preliminary version of the contract that Le Monde had access to, the parties plan to use this global event to make public an agreement between the Liberian and the UAE governments concerning the transfer of pollution rights, as provided for in the Paris Climate Agreement.

Does Liberia need informed consent?

In Liberia, the government is required to obtain prior, informed consent from communities before using their land for such deals. However, former President George Weah's government moved forward without it, according to activists and communities.

The company will also promote and engage the local communities to implement capacity-building initiatives for enhancing forestry initiatives in Liberia and is to create synergies and identify projects for COP 28 to be hosted in the UAE in 2023, including identifying forest areas and regions that can be utilized to earn carbon credits.

The MOUs will form the basis of formal contractual agreements, which Sheikh Ahmed has suggested could be unveiled at COP28 in Dubai in December. The same meeting is set to agree on the rules for his intended market -- government purchases of carbon credits that can offset emissions as part of national pledges, known as Nationally Determined ...
