Could Mauritius become an LNG hub?

In early 2021, a feasibility study was conducted by PricewaterhouseCoopers India in the first phase to assess the potential of Mauritius becoming an LNG hub for the region. In May 2022, the CEB published a Request for Information (RFI) from potential developers for the supply of electricity through barge mounted LNG power plants.

Does Mauritius use solar energy?

Mauritius has an attractive potential for solar energy, with an average annual solar radiation value of some 6 kWh/m²/day. Solar photovoltaic (PV) energy is an option due to the almost year-round intensive sunlight. To achieve the target of 60 percent renewable energy by 2030, Mauritius has commissioned six more solar farms.

Does Mauritius need a battery energy storage system?

Mauritius aims to increase the share of renewable energy sources in its energy mix, which leads to fluctuating power injection. To reduce this fluctuation from variable renewable energy sources, the installation of Battery Energy Storage Systems (BESS) is required.

Are there integrated photovoltaics in Mauritius?

According to MARENA, there are currently no building integrated photovoltaics in Mauritius. Energy efficiency is now one of the main criteria in the design of public buildings and in rental of private buildings. The Green Building Council Mauritius was set up in 2009 to promote green building and is a member of World Green Building Council.

Can offshore wind farms be developed in Mauritius and Rodrigues?

Preliminary research carried out by the Mauritius Research Council (MRC) shows potential for the development of offshore wind farms in the waters of Mauritius and Rodrigues.

What is the Smart Grid Roadmap for Mauritius?

The Smart Grid Roadmap for Mauritius was launched in December 2018 to help the CEB integrate new technologies in the power system, enhancing reliability, safety, and security.
