Who is UniStar Nuclear?

UniStar is also assisting PPL Corporation with the development of their Bell Bend Unit 1 project, which is also a U.S. EPR design. Created in 2005 by Constellation Energy and Areva, UniStar Nuclear became UniStar Nuclear Energy in August 2007 - a joint venture by Constellation Energy and EDF.

Who owns UniStar Nuclear Energy?

UniStar Nuclear Energy is a wholly owned subsidiary of EDF(Électricité de France), formed in 2007 to develop new nuclear energy facilities in the United States. Unistar has one project under development, Calvert Cliffs Unit 3 in Maryland - the reference plant for the Areva, U.S. EPR design.

What happened to Unistar & Constellation Energy?

UniStar failed to acquire the land rights from Constellation Energy (and other parties) and subsequently terminated the NMP3 project in 2013. In February 2014, after significant staff reductions the prior year, UniStar vacated its Baltimore MD office and moved remaining staff to the EDF North America Headquarters in Chevy Chase MD .
