

# Migrant workers make their own solar power

Can migrant workers contribute to a greener future?

Climate change also forces people to move. Yet governments and businesses have overlooked how migrants can contribute towards a low-carbon, greener future. To do so, they must remove obstacles, create incentives, and foster pathways to harness the potential of migrant workforces to support green transitions.

How can government support migrant workers?

Governments must integrate migrants with green skills into their labour markets, recognise qualifications across borders, and amplify skills transfer efforts. They should enlist companies, migrant organisations and local government to match workers to opportunities, while supporting local workers too.

Why did migrant workers want to work more?

Migrant workers were prepared to perform physically demanding work featuring irregular and long working hours. They could and wanted to work more because, being far away from home, they had fewer social contacts- one of the reasons why they had no 9-to-5 mentality. Wanting to work many hours, employers sometimes even had to 'apply the brakes'.

Where do migrant workers work?

Many migrants work in sectors important for green transitions, but in forms of employment that exploit both them and the environment: Malaysia's palm oil plantations exploit the country's environmental resources as well as low-skilled migrant workers from Indonesia.

Are migrant workers 'own staff'?

As the majority of migrant workers are recruited as temporary agency workers, with HR departments generally not involved, they are not regarded as 'own staff'. This status is at odds with the observation made during the pandemic that migrant workers perform vital functions in many firms.

Why is migrant labour important in Africa?

Migrant labour plays an important role in supplying workers to African mining operations, which are often located in isolated and sparsely populated regions. Today, the country hosts an estimated 429,000 international migrant workers, both from within Africa and outside the continent.
