Xinyi Energy was spun off and listed on the Hong Kong Stock Exchange. Xinyi Silicon was formed and Xinyi Solar was included in Hang Seng Index. The group had added 8 solar glass production lines (including cold repair), among which 3 production lines are in Wuhu Jiangbei, is the largest number in the industry.
