Where is Saint Pierre located?

Saint-Pierre (French pronunciation: [se pjɛʁ](i)) is the capital of the French overseas collectivity of Saint Pierre and Miquelon, off the coast of the Canadian island of Newfoundland. Saint-Pierre is the more populous of the two communes (municipalities) making up Saint Pierre and Miquelon.

The islands are a well-known separate country-level entity among many radio amateurs, identifiable with ITU prefix "FP". Those visiting, mainly from the US, activate Saint-Pierre and Miquelon every year on amateur frequencies.

What is the difference between Saint-Pierre and Miquelon-Langlade?

Although containing nearly 90% of the inhabitants of Saint Pierre and Miquelon, the commune of Saint-Pierre is considerably smaller in terms of area than the commune of Miquelon-Langlade, which lies to its northwest on Miquelon Island.

How many people live in Saint Pierre & Miquelon?

Until 1945, there existed a third commune in Saint Pierre and Miquelon: L'Île-aux-Marins. The commune of L'Île-aux-Marins was annexed by the commune of Saint-Pierre in 1945. The population of Saint-Pierre in 2019 was 5,394,^[2] many of whom are of Basque, Breton, Norman or Acadian descent. [citation needed]

How did Saint-Pierre and Miquelon become a territory?

After the 1958 French constitutional referendum, the territory of Saint-Pierre and Miquelon was asked to choose one of three options: becoming fully integrated with France, becoming a self-governing state within the French Community, or preserving the status of an overseas territory; it decided to remain a territory.

Does Saint-Pierre and Miquelon have a health care system?

Saint-Pierre and Miquelon's health care system is entirely public and free. In 1994, France and Canada signed an agreement allowing the residents of the archipelago to be treated in St. John's.
