Who is entitled to paid paternity leave in Seychelles?

Paternity Leave (1)A male worker,resident in Seychelles,under a contract of continuous employment or for a fixed term or a part-time male worker,is entitled to paid paternity leave of 10 consecutive working days.[regulation 19A (1) amended by regulation 2 (b) of SI 32 of 2018]

What if a worker is compelled to move in Seychelles?

(b)wherever a worker is compelled,by reason of a transfer or other circumstances of his employment,to move from the house he owns or occupies rent-free in Seychelles to quarters provided by the employer. 43. Transport and uniform

How do I obtain a job card for an unemployed Seychellois?

(1)Every unemployed Seychellois seeking employment and every employed Seychellois seeking alternative employment shall furnish to the Employment Services Bureau the particulars specified in subsection (2) and obtain from the Employment Services Bureau a job card. (d)any other prescribed particulars.
